Addition to point 10: planting a hedge on the south boundary shared with Dene Place was also discussed. Due to heavily shaded canopy, poor soil conditions and ongoing maintenance issues; it was decided not to pursue proposal

- 3.11 G+F Ecological Report Ashley circulated copies to committee. Agreed to review and revise the plan as 10 years since originally written Action John W Ashley Brown and Eddie Woodhouse to revise
- **3.12** Water Harvesting There were long discussions on the viability of proposals put forward. Rob Treble suggested the possibility of devising a pump powered by solar panels (costs £6000) Concerns expressed over water in open tank close to our outdoor social area. Also it was argued we are trying to reduce hand watering as so time consuming and demanding on volunteers. In addition the oversupply of water in winter and shortage of water in summer was discussed. Agreed to harvest more water off the polytunnels by adapting the original polytunnel. Action Rob T to attach guttering to feed water butts on the original polytunnel.
