6.	H&S: Traffic mirror	GR has researched a convex mirror which will have a viewing distance of 13m. It is 600mm in diameter. It was agreed to discuss with RT before making a decision.	GR/RT
7.	Finance Report	Our finances are in a healthy position. We have nearly £12,000 in the bank and about to get a small dividend on our contingency account. Sales are lean but understandable at this time of the year. Expenses have mainly been on cost of sales and maintenance. John has bought more asparagus (see below). Pollarding was more expensive than anticipated but they did take away the old tree as well and shred all the branches which we have used on paths etc.	
8.	Garden update	We have developed a third asparagus bed so more crowns have been purchased which will be planted next month. There have been issues with the size of the fruit cage which has meant that we may have enough poles to make a second pea cage. The weather has not been kind to us and most of the seedlings are not growing on due to the cold. John has bought new modular seed trays which are smaller than the ones we currently use meaning we get 60 modules in a smaller tray. This has positive consequences for both storage and compost use. He has only bought 5 for now to see how they perform. The space between the walls has now been dug over and is ready to grow vegetables for the food bank.	
9.	Allotments	The plot at the bottom of the allotments has now been taken over by two ladies who appear to be very keen. A couple appeared to be interested in the ½ plot next to the potting shed but have not made any effort to come and see the plot, so it may be offered to the next person on the waiting list. MT has changed the gate code and has put together a new mowing rota which will be issued in due course.	MT
